### Voice to Lead & International Nurses Day

For more than 45 years now, ICN has been publishing the International Nurses' Day (IND) resource. These resources are provided to over 130 countries with a potential audience of over 20 million nurses globally. Thanks to your contribution, this resource has been used by the nursing community across the world as a strategy to improve health and health systems and has improved our reach and engagement with people from all over the world. It has improved our ability to share individual's stories to the world.

In 2017, the IND was entitled 'Nurses: A Voice to Lead – Achieving the Sustainable Development Goals.' This was the start of a new direction for IND as for the first time it changed from a hard copy resource to a fully dedicated website and a video. In 2018, the IND theme was 'Nurses: A Voice to Lead – Health is a Human Right'. The success of this publication continues to grow and there is particular interest across the global community in regards to the Case Studies

Plans are underway for the 2019 International Nurses Day and, once the new theme has been approved by the ICN Executive Committee – we will announce it and start work on the logo, posters, stickers and other designs, for which we will ask you to provide translations into your own language.

### Invitation to submit a case study for the 2019 International Nurse Day Publication

We are pleased to announce you the IND 2019 theme: "Nurses: A Voice to Lead Health for All" For 2019, IND will address the challenges the world faces because of becoming increasingly connected through travel, trade and cultural exchange and its influence on health and wellbeing. We aim to demonstrate the importance of global health issues and highlight how nurses are pivotal leaders in addressing these.

A sample of the topics to be addressed in this publication include, but are not limited to:

- Global health challenges, e.g. non-communicable diseases, mental health, communicable diseases and epidemics
- Societal issues, e.g. conflict, migration, technology and innovation
- Health Systems, e.g. Universal Health Coverage, population and Primary Health Care.

ICN would like to invite you to share your and your members' stories in the form of a case study to be a part of the IND 2019. We are looking for relevant case studies for use in the IND resource. We are interested in the work of nurses at any level (front line nurses, managers, directors, chief nurses, NNAs) as individuals or in teams.

### **International Nursing Review**

ICN's official journal, the International Nursing Review, has been inducted into the International Academy of Nursing Editors' Nursing Journal Hall of Fame as one of its inaugural recipients. Sue Turale, INR's editor, was present at the 37th Annual Meeting of the International Academy of Nursing Editors in Boston, USA on 7 August to receive the award in person. The Nursing Journal Hall of Fame was established to recognise scholarly nursing journals that have 50 or more years of continuous publication and sustained contributions to nursing knowledge. Nursing research has been published in ICN's International Nursing Review since 1953, helping to shape nursing practice and improving the lives of people all across the world.

# Nursing Policy

Earlier this month, we released a new position statement on Evidence-based safe nurse staffing which calls for increased investment in safe, effective and needs-based nurse staffing levels in order to improve patient outcomes and create positive practice environments.

### ICN revision of the Code of Ethics for nurses

ICN has received 22 official applications of representatives affiliated to different NNAs to be part of a group of ethical leaders who will undertake revision of the ICN Code of Ethics. The revised Code will be used to strategically foster nursing and healthcare in an ever-changing and more digitalised society with increasingly complex ethical challenges and moral dilemmas.

# **P**rogramme News

## TB/MDR\_TB Project

The World Health Organization (WHO) has announced landmark changes in MDR-TB treatment regimens. The first important change is a new priority ranking of the available medicines for MDR-TB treatment, based on a careful balance between expected benefits and harms. Treatment success for MDR-TB is currently low in many countries. This could be increased by improving access to the highest-ranked medicines for all patients with MDR-TB.

The second important change is a fully oral regimen as one of the preferred options for MDR-TB treatment. Injectable agents cause pain and distress to patients, with many experiencing serious adverse effects that often lead to treatment being interrupted.

The WHO rapid communication aims to encourage and prepare countries to implement the upcoming new WHO policy guidelines on MDR-TB treatment which will be released later this year. WHO is also establishing a multi-stakeholder Task Force to coordinate support to national TB programmes in their rapid transition to the key changes envisaged.

faculty includes: Professor Jane Salvage (GNLI 2018 Programme Director); Professor Diana Mason (GNLI 2018 Co-facilitator); Howard Catton (ICN Director of Nursing & Health Policy); Dr Isabelle Skinner (ICN CEO); Dr Alessandro Stievano (ICN Associate Director of Nursing & Health Policy); and guest speakers: Dame Christine Beasley and Dr Barbara Stilwell.

GNLI 2018 is a highly competitive five-month programme to support nursing leaders in building their political and policy competence. The programme comprises three modules:

- Module 1: Induction, 2 July 7 September
- Module 2: Residential workshop, Geneva, 8-14 September
- Module 3: Implementation, 15 September 30 November.

### Leadership For Change

The second LFC training courses in **China**, sponsored by Johnson & Johnson and delivered by ICN in collaboration with the Chinese Nursing Association, were held 23-28 July. Workshops 1 and 2 of the ICN LFC Programme were delivered as a compressed programme over the course of six days. The programme welcomed 36 participants, including 23 senior level Directors and Associate Directors of Nursing from 12 provinces in China, and 13 mid-level managers who recently completed all three workshops of the LFC programme. The 13 mid-level managers were in attendance to gain additional experience with the programme and serve as facilitators for group activities. The senior level attendees enabled the programme to be delivered at a rapid pace. The participants formed into teams and developed plans for LFC projects including:

- · Promotion of patient safety: Prevention of patient falls
- · Development of a plan to establish and promote a nurse managed clinic in China
- Improving diabetes mellitus management among pregnant women through a digital education programme
- Improving leadership and management competencies of nurse managers
- Improving medication safety of inpatients in four hospitals in Shanxi and Qinghai Provinces
- Improvement of patient safety during transfer
- Improving nurse job satisfaction through changing job characteristics

The workshop was delivered by Kristine Qureshi, Associate Dean for Research & Director of Global Health University of Hawaii at Manoa, and supported by Alessandro Stievano, ICN Associate Director for Nursing and Health Policy and Marcia Petrini, Dean of Wihan University.

This cohort is expected to finish at the end of December. Thanks to our train the trainer model, training can now continue across the 12 provinces over the next two years helping many more nurses with their leadership for change journey.



## 10th ICN Nurse Practitioner/Advanced Practice Nursing Conference

The 10th ICN Nurse Practitioner/Advanced Practice Nursing Conference was held 26-29 August in Rotterdam, Netherlands. The three-day conference, attended by 1,500 delegates looked at nurses' leading role in the transformation of care, with a particular focus on universal health coverage, the Sustainable Development Goals and human resources for health. ICN was represented at the Conference by Annette Kennedy, ICN President who spoke at the opening ceremony; David Stewart, ICN Associate Director, Nursing and Health Policy, who spoke on the centrality of nursing's role in addressing global health challenges, and Professor



Thomas Kearns, ICN's Interim CEO, who spoke on expanding advanced nursing practice across the scope of mental health nursing. The next ICN NP/APN Conference will be held in Halifax, Nova Scotia, Canada on 30 August – 2 September 2020. Find more information on the NP/APN 2020 website.
